

## **Participant Declaration**

I hereby accept and submit myself to the policies, rules and regulations of the Centre for Polish-Russian Dialogue and Understanding (as an organiser) and any amendments thereto, which may be made while I am a participant at the "International Summer School. The Second World War on trial. Perspectives of international law and historical research" (30 August-5 September 2020, Łękuk, Republic of Poland), hereinafter referred to as the "Summer School". The law applicable for any dispute regarding Summer School is the Polish Law and the place of jurisdiction is Warsaw, Republic of Poland.

I hereby accept that as a participant I am required to organise private insurance coverage for the attendance of the Summer School. It is a requirement for every participant to be health insured for the duration of the workshop and to make sure that insurance will be valid for a stay in Republic of Poland. The Centre for Polish-Russian Dialogue and Understanding, hereinafter referred to jointly as "institutions", will not insure participants and strongly recommends an accident and liability insurance.

I hereby commit to carry and produce upon request the institutions a document confirming being in a possession of an adequate above-mentioned private insurance

## **Information Clause**

According to Article 13 para. - 3. Your personal data will be processed for the following purposes:
- 1) educational, administrative and operational functions in connection with the preparation and realization of the "International Summer School. The Second World War on trial. Perspectives of international law and historical research" (30 August-5 September 2020, Łękuk, Republic of Poland), hereinafter referred to as the "Summer School" (Article 6(1)(a) of the GDPR);
- 2) implementation of legal obligations imposed on the Centre for Polish-Russian Dialogue and Understanding on the basis of the provisions of law generally applicable on the territory of the Republic of Poland since data processing is necessary for the Centre for Polish-Russian Dialogue and Understanding to fulfil those obligations (Article 6(1)(c) of the GDPR);
- 3) establishing, pursuing or defence against claims in connection with the Summer School or in connection with the processing of your personal data since data processing is necessary to pursue the legitimate interests of the Centre for Polish-Russian Dialogue and Understanding (Article 6(1)(f) of the GDPR).
- 4. The recipients of your personal data may be:
- 1) entities which, pursuant to the provisions of law generally applicable on the territory of the Republic of Poland, have the right to request access to such data;
- 2) entities providing postal services, payment services, ICT services as well as legal services and debt collection services to the Centre for Polish-Russian Dialogue and Understanding.
- 5. Your personal data will be processed for the period necessary to achieve the aforementioned objective regarding retention of periods set out in the separate regulations.
- 6. You have the following rights:
- 1) the right to require the data controller to provide access, rectify, erase or restrict the processing of your personal data and the right to object to the processing, as well as the right to transfer your data;
- 2) withdrawal of consent to the processing of personal data at any time without affecting the legal processing compliance established on the basis of prior consent;
- 3) the right to lodge a complaint with a supervisory authority within the meaning of the GDPR, i.e. the President of the Office for the Protection of Personal Data in Poland (UODO);
- 4) the right to contact the Data Protection Officer at the Centre for Polish-Russian Dialogue and Understanding in all matters related to the processing of your personal data.
